1. Invitation

Re-E- tenders are hereby invited from the reputed, experienced and bonafide Contractors having sufficient credential and financial capabilities for the following nature of work.

- In the event of e-filing, intending tenderer may download the tender documents from the website <u>www.wbtenders.gov.in</u> directly with the help of the Digital Signature Certificate and submit the Technical Bid as well as Financial Bid online on or before the last date and time given in the Notice Inviting e-tender.
- Both Earnest Money and Tender Fee are to be deposited in favour of WBSFP&HDCL through ICICI Bank Payment Gateway failing which the tender will be treated as informal.
- Both Technical and Financial Bid are to be submitted concurrently duly digitally signed in the website <u>www.wbtenders.gov.in</u> as per scheduled date and time. The documents submitted by the bidder should be properly indexed and self-attested with seal.
- The Financial Offer of the prospective tenderers will be considered only if the Technical bid of the tenderer is found valid by the Tender Committee of the WBSFP&HDCL. The decision of the Tender Committee will be final and binding on all concerned and no challenge against such decision will be entertained.
- The list of the qualified bidders will be displayed on the website on the scheduled date and time.

2.Scope of Work

- I. The WBSFPHDCL, hereinafter referred to as the Tender Inviting Authority, seeks bids for execution of the work, as specified in Annexure I, from reputed, experienced and bonafide Contractors.
- II. The successful Bidder has to complete the entire work within stipulated time without fail.

3. Date and Time Schedule

4. Eligibility criteria for participation in the Tender

- i. The prospective Bidder must have valid Trade license/ Certificate of Enlistment, PAN, GST Registration Certificate, IT return for any two years within the period from 2016 17to2018 -19.
- ii. The prospective Bidder should have credential for execution of any type of civil/ plumbing work of an amount not less than Rs.3,00,000 (Rupees three lakh)at any State/Central Government Organizations or State/Central Govt. Undertakings or Statutory Bodies or Local Bodies or Parastatals or any private enterprise within the last two completed financial years.
- iii. The Bidder must have the copy of the Payment Certificate or Work Completion Certificate, as the case may be, issued under the signature of the Competent Authority. The said Certificate should contain the particulars of the work completed, period of work and the total value of work.

5.*Mandatory documents requirement*

The Bid proposal shall contain the signed copies of the following-

i. NIT DOCUMENT

ii.Payment Certificate or Work Completion Certificate as referred in Clause 4 above

iii.PAN Card

iv.ValidTrade License/ Certificate of Enlistment (valid as on 31.03.2020)

v.Income Tax Return for any two years within the period from 2016 – 17 to 2018 - 2019

vi. GST Registration Certificate

vii.Earnest Money Deposit

Failure in submission of any of the above documents may render the Bidder liable to be rejected.

6. Financial Proposal

The Financial proposal should contain-

Bill of Quantity (BOQ):-The supplier is to quote the rate online in the space marked for quoting rate in the BOQ. Aassessment of the successful bidder will be done on the cumulative price of the offered rate of all items taken together

The participant will be rejected in case it is uploaded in the Technical Bid.

GENERAL TERMS AND CONDITIONS

1. Earnest Money

I. Online Deposition of Earnest Money and Tender Fee

The Tenderer desirous of taking part in the tender have to deposit Earnest Money and Tender Fees through ICICI Bank Payment Gateway. The Earnest Money @ Rs. 16,000/- will be deposited to the ICICI Bank A/C No.- 105605500441, IFSC No. -ICIC0001056, MICR Code – 700229032.

II. Refund of Earnest Money deposit

The Earnest Money of all unsuccessful tenderers will be refunded by the WBSFPHDCL within 30 days from the date of finalization of tender on receipt of application from the tenderers. In case of successful tenderer, the Earnest Money deposit will be released after 90 days counted from the date of completion of supply. No interest on Earnest Money will be paid by the Corporation.

III. Forfeiture of Earnest Money deposit

Earnest Money deposit is liable for forfeiture in the event of:

a) Withdrawal of offers, while offers are under consideration during the validity period.

b)Non acceptance of supply order.

c)Any unilateral revision made by the tenderer during the valid period of the offer.

2. Responsive Bidders

Prospective applicants are advised to note carefully the minimum qualification criteria before tendering the bids. Conditional/ incomplete tender will not be accepted under any circumstances. Bidders fulfilling all conditions and criteria set forth and qualifying in the Technical Bid as well as making submission of Financial Bid in stipulated manner shall be considered responsive.

3. Rate Validity

The rate shall remain effective ordinarily up to 90 days from the date of acceptance of Tender which may be extended further with mutual consent between the bidder and WBSFPHDCL unless terminated prematurely at its discretion and satisfaction.

4. Evaluation of Tenders

- i. All Tenders will be evaluated and compared on the basis of the submitted documents. The Tender Inviting and Accepting Authority will determine the eligibility of each bidder through a Tender Committee. The bidders shall have to satisfy all the clauses specified in eligibility criteria.
- ii. The Bidders may remain present at the office of WBSFPHDCL during opening of Bids, if they so desire.

iii. Bids complete in all respect will only be accepted and qualify for next stage of evaluation.

iv. Lowest quoted rate shall normally be accepted. However, the Tender Inviting Authority reserves the right to accepting a bid other than the lowest on a specific ground to be recorded in writing.

iv. The Tender Inviting Authority does not bind itself to accept any or all bids and reserves the right to reject any or all bids without assigning any reason whatsoever.

6. Issue of work order

The work order will be issued to the L1 Bidder for execution of the work following the specification and estimate prepared and vetted by the competent Authority

7. Completion period of work

The contractor shall undertake to complete the work within 21 days from the date of placing the work order.

8. Right to accept any bid and/ or to reject any or all bids

The Corporation reserves the right to accept or reject any or all bids and to annul the tendering process and all bids prior to issue supply order, without thereby, incurring any liability to the affected Bidder or Bidders or any liability to inform the Bidder of the ground for such action.

9. Delay in work

It is emphasized by the Corporation and understood by the contractor that the period of work, stipulated in the work order is the essence of the work. It is admitted by the contractor that any delay in execution may obviate the necessity of work and thereby affect the interest of the Corporation. If the reason of delay is beyond the control of the Bidder, then it should be communicated to the Corporation in writing for its necessary intervention.

10. Grounds for Disqualification

- i. During scrutiny or at any stage of bidding process or even after issuance of work order, if it comes to the notice of the Tender Inviting Authority that the Bidder has wilfully made any misleading or false representation in the documents/ statements and attachments submitted as the proof of the qualification requirements
- ii. If the Bidder fails to complete the work within the period stipulated in the work order due to his own fault/ inconvenience

Then in both the cases, the Corporation shall reserve the right to forfeit the Earnest Money deposited by the Bidder and also debar him from participation in the Tender process of the Corporation for the next 3(three) consecutive years.

11.Disputes

Any dispute arising out of non-compliance of any Terms and Conditions of the Tender, it shall be referred to sole Arbitrator, who shall be appointed by the Corporation in accordance and subject to the provision of the Arbitration and Conciliation (Amendments)Act,2015.

The place of Arbitration will be Kolkata and the language shall be English. The Award of the Arbitrator shall be binding on both the parties. All disputes and Court cases are subject to the Jurisdiction of the Calcutta High Court only.

12.Negotiations

It is clarified that normally no rate negotiation will be done and therefore the Bidders should quote their lowest prices only, however, the Corporation may negotiate the rates with the L1 Bidder in exigencies, if required to do so.

13.Payment of Bill

i. Measurement of the work will be taken by the Authority within 5 days from the date of completion of work.

ii.92% of the Bill value will be released to the Contractor within 7 days from the date of submission of Bill in duplicate.

iii.Rest 8% of the claimed amount as well as the earnest money will be kept in the account of the Corporation for the next 30 days as security deposits, which will be released after completion of the defect liability period.
