

In response to the various queries of the intending bidders in pre-bid meeting, the following addendum and corrigendum are being made in the terms and conditions of the EOI

**REVISION IN TERMS & CONDITION :**

1	<b>Eligibility criteria for participation in the Tender:4(i)</b>	The prospective Bidder should have single credential for execution of new construction of poly house / green house with fan pad cooling system of an amount not less than Rs. 40,38,000/- (Rupees Forty Lakh Thirty Eight Thousand only) at any State/Central Government Organizations of State/Central Govt. Undertakings or Statutory Bodies or Local Bodies or Parastatals within the last five financial years i.e. F.Y. 2018-19, 2019-20, 2020-21, 2021-22 & 2022-23 prior to the date of issue of the tender notice.	The prospective Bidder should have - 1. <b>single credential for execution of new construction of poly house / shade net house / green house of an amount not less than Rs. 40,38,000/-</b> (Rupees Forty Lakh Thirty Eight Thousand only) <b>And</b> 2. Experience for installation of fan pad cooling system in execution of new construction of poly house / green house at any State/Central Government Organizations of State/Central Govt. Undertakings or Statutory Bodies or Local Bodies or Parastatals within the last five financial years i.e. F.Y. 2018-19, 2019-20, 2020-21, 2021-22 & 2022-23 prior to the date of issue of the tender notice.
2	<b>Warranty Period:</b>		If any damage occurs due to poor workmanship or materials during construction within the 6(six) months after successful completion of the work and hand over the entire project to the appropriate authority, the agency will have to repair the entire damaged or faulty portion of work free of cost except damage occurs due to natural calamity or mishandling. The EMD will be converted to Security Deposit in case of successful bidder, who will get the work order. Agency who will claim Exemption in case of deposition of EMD they will have to deposit Security Deposit @ 3% i.e. Rs. 3,02,850/- (Rupees three lakh two thousand eight hundred fifty)only separately if they become successful bidder and get work order. The Security Deposit will be released after completion of warranty period.
