- 1. Terms and conditions for On-site Comprehensive Annual Maintenance of IT Infrastructural work shall valid from 01.07.2021 30.06.2022 and the present location of the equipments.
- 2. The contract may be extended for another two years with the same rate after completion of the initial contract satisfactorily and approval of the tender committee/authority.
- 3. A dedicated email id and mobile number has to be provided to register complaint calls by the Department. There should be a dedicated person (Single Point of Contact) of the vendor who shall be contacted for service.
